- 2. For <u>FINAL SITE PLAN REVIEWS</u>, the submission must include <u>ALL</u> outside agency approvals as well as five (5) sets of sealed site plans.
- 3. To allow City Staff sufficient time to review a submission before advertisement, return comments to the applicant and avoid the possibility of reaching the public hearing without a staff recommendation for approval, it is highly recommended that all site plans be submitted to the City of Seaford at least 15 business days prior to the advertising deadline.
